Erin Jackson has been appointed as the Grievance Committee Chair. We continue to have complaints about classrooms not being cleaned. A Google Form will be forthcoming where you may report any problems with cleaning problems at your school or in your room. Let us know if you would like to attend the Region 3 conference. Please remind teachers and other staff when you have your 10-minute site meeting that teachers and other staff members should refrain from touching students for any reasons. Educators should not take photos of students, especially with their personal cell phones. Educators should also limit their lectures to lesson objectives. Just like at your holiday table, no talks of politics or religion. I will use Constant Contact to reach everyone about organizing, rallies, elections, etc.
